TERMS & CONDITIONS

1. The Hirer must be between the ages of 21 and 69.
2. The Hirer must produce I.D. being current driving licence (full, if not clean hire will be at the discretion of the Branch Manager) and 2 household bills (all documents to have matching addresses).
3. Daily hire runs from 8.00am to 8.00am – hires started after 8.00am still finish at 8.00am.
4. UK travel: £500 deposit payable by debit or credit card only on collection of the vehicle as excess of any insurance claim (refundable on condition of hire when returned). The Hirer is liable for the insurance excess of £500.
5. Overseas travel: by arrangement only. Green Card insurance is available at £100.00 payable in advance at the time of booking the hire. The deposit is £1,000. Vehicles must not be taken out of the UK without Trident Trailers consent.
6. The hire charge is to be paid on collection of the vehicle. No refund is available for early return.
7. Full AA Relay Cover & Self-Drive Hire Fully Comprehensive Insurance is included within the UK. The Self-Drive Hire Fully Comprehensive Insurance also includes a trailer. Land Rover Assistance covers UK and Europe.
8. Mileage allowance of 250 miles per day (additional mileage charged at 20p per mile).
9. The Hirer will be responsible for the fuel reading and on return should be the same. The cost of any shortfall will be born by the Hirer. The Hirer is also liable if incorrect fuel is used.
10. The Hirer will be responsible to check daily the correct levels of engine oil and coolants, tyres etc. Failure to do so may result in damage to the vehicle for which the Hirer will be responsible.
11. All fines incurred by the Hirer for infringement of traffic laws or regulations and tolls are the responsibility of the Hirer; also liable to pay our reasonable administration charges should we have to deal with these matters.
12. The Hirer will be responsible for the stereo front and the number plate.
13. The Hirer will be responsible for the cleanliness of the vehicle interior and exterior. If the vehicle is returned unclean a charge will be made for a valet at £45.00.
14. Trident Trailers cannot be held liable for damage/theft of customer belongings/goods in the vehicle/trailer.
15. Trident Trailers operate a strict no smoking policy in all vehicles. Any offender will forfeit their deposit.
16. Vehicles left whilst hiring are done so at the owners' risk.
17. Failure to return the vehicle on time without prior consent from the Branch Manager will incur a penalty charge together with any additional costs incurred by Trident Trailers Ltd.
18. Failure to return the vehicle at the agreed time on the last day of hire does mean the vehicle is not insured and renders the hirer to criminal prosecution.
19. All charges (except deposit) are subject to VAT at the current rate ruling.
